## Dog Policy

I (the above referenced Owner) agree to the following regulations and conditions while staying at the San Luis Resort (“Hotel”) with my dog:

**RULES:**

- Dog must be fully up to date on all vet recommended vaccinations and care.
- Dog cannot weigh more than 40 lbs.
- No more than two dogs per room allowed.
- Dog may not be left alone in room, unless it is secured in an appropriately designed kennel.
- Dog walking only in the designated grassy area at the back of the Hotel. Plastic bags and disposal are provided.
- Dogs must always be on a leash or in a carrier if outside your guest room.
- Dogs (except service dogs) are not permitted in restaurants/bars, spa, or meeting rooms.
- Dogs disturbing other guests or causing damage will be asked to leave without a refund of any Fees.

**HOUSKEEPING:**

Housekeeping will service your room **upon request** between 9am-5pm daily. Dogs cannot be in room while housekeeping is servicing your room unless dog owner is present.

**FEES:**

- A non-refundable fee of **\$150** for the first dog, plus an additional **\$50** for a second dog plus tax is required upon check-in for special handling of the room after your departure
- Any damages or additional cleaning bills resulting from your dog will be billed to your credit card on file.
- If your dog is left in the room unattended and disturbs other guest, either a non-refundable \$250 fee or a fee for any other compensation given to that disturbed guest will be applied automatically to the credit card on file for your room.

**DOG WALKING SERVICES:**

Dog walking services are available upon availability see concierge. By engaging Hotel in the provision of such dog walking services, I attest that my dog has not harmed or shown aggression or threatening behavior towards any person or any other dog and does not suffer from any life threatening or contagious condition that may be exacerbated by exposure to other dogs or by such dog walking services. I hereby grant Hotel permission to act on my behalf, and in my dog’s best interest, by obtaining veterinary care, should deem it necessary for the health and wellbeing of my dog and I further agree to pay for or

reimburse the cost of any and all veterinary or reasonable necessary services whose costs Hotel may incur. I agree to release and hold harmless Hotel from all liability should my dog become lost, injured or suffer any damage not due to the gross negligence of Hotel.

**RELEASE:**

In consideration of the Hotel permitting me to house my dog at the Hotel for the duration of my stay, I, and my successors and assigns, release and discharge the Hotel and/or its direct and indirect parents, subsidiaries and affiliates, and each of their respective shareholders, members, managers, directors, employees, and officers from all actions, suits, debts, bills, contracts, controversies, agreements, promises, trespasses, damages, judgments, claims and demands whatsoever, in law or in equity, known or unknown, which I or my successors or assigns ever had, now have or hereafter can, shall or may have, and including, but not limited to, any claims relating in any way to my stay at the Hotel relating to the presence of my dog on or about the Hotel or neighboring premises against or relating to the Hotel or my engaging of the Hotel to provide dog walking services.

**INDEMNIFICATION:**

I further agree that I shall assume full and complete responsibility for any personal injury or property damage caused by the dog suffered by any guest, employee(s), or invitee(s) of the Hotel. In the event such personal injuries or property damage should arise, I agree to indemnify, defend and hold harmless the Hotel and/or its direct and indirect parents, subsidiaries and affiliates, and each of their respective shareholders, members, managers, directors, employees, and officers, for any claim(s) which may arise.
